All winners must be 18 years of age or older, unless otherwise stated and/or posted.

### **1. Entering Contests, Choosing and Contacting Winners**

Winners of random e-mail contests will be chosen at random from e-mails received.

Entrants must send entries using the correct contest entry e-mail address, subject line, and any other specific entry information requested in the contest announcement. Groknard is not responsible for and will not consider incomplete or incorrect entries, or e-mails sent but not received by Groknard for any reason, as potential contest winners.

Winners of all contests will be contacted at the "sender" e-mail address used to enter the contest, and the person receiving and replying to the winner announcement e-mail will be considered the winner unless they specify another person within the reply e-mail as the winner. Groknard will mail the contest prize to the address supplied by the recipient of the winner announcement e-mail.
